Vacations

- Payment is still required to reserve your child's space when your family takes a vacation.
- Provider is allowed two weeks paid vacation per year and a Christmas break, reopening shortly after the New Year, (approximately 10-13 days determined by the SRVUSD)
 - o The two weeks break down to:
 - One week for Spring Break, as determined by the SRVUSD
 - The week of July 4th, plus July 4th (6 days of care total). Dates will be provided each year for clarity.

Illness

- Children MUST be up to date on all immunizations and be in general good health.
- It is very important to keep provider up to date on any new immunizations received while in providers care.
- Child may not be brought to facility if he/she has any of the following illnesses:

o Fever (100°+)

o Diarrhea

Head Lice

o Impetigo

Vomiting

Green Nasal Discharge

Ring Worm

o Conjunctivitis (pink eye)

Anything Contagious

- Child is not allowed to return to facility until after **48 hours** have passed symptom-free (without medication such as Tylenol).
- All prescription medications need to be provided by parent with a signed permission slip for provider to administer stating specific instructions.
- If your child needs an EpiPen or EpiPen Jr. to be administered, the parent will provide instructions on how to administer it to the provider. This is considered part of Incidental Medical Services (IMS), in accordance with Health and Safety Code Section 1597.54(h).
- If we call or text you to pick up your child due to illness, you must come within one hour of being notified.

It is not fair to your child, other children, or provider to be exposed to any known illnesses.

Bumps and Scrapes

• If your child falls and gets a scrape, we will do our best to let you know at pick up time. The provider will text one parent/guardian a photo and notification if the child gets a bump or scrape on their face.

Difficult Goodbyes

- Separation anxiety can make goodbyes tough on the child, parent and provider.
- It is easier to say goodbye **quickly** and give your child a clear indicator that you will be back for them; sneaking out only increases the anxiety they feel. Please limit drop-off and pick-up to 5 minutes or less.
- Please feel free to contact me at any time throughout the day if you would like to check on your child. I will get back to you as soon as possible.

Miscellaneous

- Please dress your child in **play clothes only**! Close-toed shoes are preferred. Feel free to leave an extra set of shoes at school.
- Parents will provide extra clothing and a blanket, **labeled**, (blanket is washed daily at the school). NKP is not responsible for lost or damaged items.
- All articles of your child's clothing should be labeled with his/her name as it is very difficult to keep track of otherwise.
- For health and safety reasons, please do **not** bring any items from home aside from the child's school bag and/or reusable water bottle. Exceptions can be made with notice.
- Parents are responsible for updating emergency contact information, immunization records, etc.
- Please notify me via email, home phone, or text, by 9:00am, if your child will not be attending daycare for the day.
- Sunscreen your child every day.
- Please note that NKP's driveway can be slippery when wet.
- Please leave parent/guardian email addresses as I often communicate this way:

Unforeseen Circumstances

 Hours, rates, and other contract terms are subject to change due to unforeseen circumstances including but not limited to wildfires affecting air quality; power shutoffs; and pandemics. Advance notice of changes will be given whenever possible.



Termination

- Parents will give the provider two weeks written notice if leaving daycare facility. Two
 weeks fee is still required, whether your child comes to daycare or not.
- The provider can terminate the contract at any time without advance notice.
- There will be a **one month** trial period to ensure that this is a good fit for both the provider and the family. Your feedback is important for the provider to ensure we do the best we possibly can for each child.
